#### JOB PURPOSE

A proactive member of the Buoy yard team able to carry out duties as assigned by the Buoy Yard Supervisor or acting deputy within own competency in a safe and efficient manner, and in line with business objectives.

KEY RESPONSIBILITIES	Buoy operations	<ul style="list-style-type: none"><li>▪ Carry out routine inspections and servicing of the plant, in accordance with published procedures, and assist in higher-level plant maintenance as necessary.</li><li>▪ Undertake refurbishment of all buoys to current TH standards.</li><li>▪ Comply with workplace health and safety policies and other relevant legislation.</li><li>▪ Complete all required reports accurately and in a timely manner.</li><li>▪ Undertake tasks such as:- general labouring, water jetting, driving, assembly, slinging, station attendant, minor building maintenance, grounds maintenance, mechanical handling, technical assistance, plant servicing, supporting helicopter operations, paint spraying, grit blasting, crane driving, craft support, progress chasing, solar work, and other similar duties.</li><li>▪ To be accountable for the stores issued for the execution of assigned tasks.</li><li>▪ To keep accurate records of work as required by the Buoy Yard Supervisor.</li><li>▪ Undertake out station duties around the Trinity House estate as requested.</li><li>▪ Undertake additional tasks and responsibilities as assigned or necessary, within the scope of the role.</li></ul>
